

**Welcome to the Eagle Farmers' Market!** Vendor spots are open to local farmers, gardeners, businesses, and community organizations. The Market will be held in the Eagle Municipal Building parking lot on Mondays (June 24, July 8 & 22, August 5 & 19, and September 9). Vendor application is for all market dates.

The Farmers' Market is held "Rain or Shine". There is no fee for vendors, but pre-registration is required to hold a booth. Sales will be from 4:00 -6:00 p.m. only. No electricity will be provided. Produce, plants, food and limited artisans/crafters are welcome to attend all season. All vendors are expected to clean up their booth area after each market.

This is a market where vendors can sell only what they create or produce themselves. Resale of items purchased elsewhere is prohibited. To qualify as a producer, you must own or rent land on which your products are grown. You must plant, maintain, harvest, and market the produce you sell at the Eagle Farmers' Market. Vendors that only sell non-taxable items, such as fruits and vegetables for home consumption, do not need a seller's permit from the Wisconsin Department of Revenue. No pre-made food or food services will be allowed without a seller's permit. Baked goods, canned goods, and on-site prepared foods must follow all Health Department rules. All items displayed or literature posted at the market must represent or relate to the vendors' goods for sale.

Persons selling must be family members or paid employees. No brokers, agents or commissioned sellers may sell produce at the Market. Vendors shall make available for inspection those lands or areas on which produce sold at the market is raised or produced. Only Wisconsin grown or produced items that meet all applicable federal, state and local rules and regulations and that are approved by the Market Manager may be offered for sale/display.

It is the Vendors responsibility to have ALL of the necessary paperwork, such as licenses and permits, filed with the County and State prior to selling at the market and MUST comply with their rules and regulations while selling at the market. (The Health Department will conduct random inspections.) Vendors who use a scale must have the scale inspected and licensed and comply with all regulations as determined by the Department of Weights and Measures prior to use. If you are a new food vendor, you must have the necessary permits from the health department.
